NO.2293- E- IN exercise of the powers conferred by sections 4 and 5 of the Charitable Endowments Act - VI of 1890, and upon the publication and with concurrence of Meharani Lakshmivati Saheba, Widow of Late Maharaja Lakshmishwar Singh Bahadur, G.C.I.E. of Darbhanga, the present proprietress of the properties concerned, the Government of Bihar and Orissa in the Ministry of Education are pleased to direct that the properties of which the particulars are contained in the first Schedule hereunder written, shall as from time to time the date of the first publication in the Bihar and Orissa Gazette of the Notification vest and be henceforth vested in the Treasurer, Charitable Endowments for the territories subject Government of Bihar and Orissa to be held by his successors (subject to provisions of the said Charitable Endowments Act, 1890), and by rules from time to time framed thereunder by the Governor General in Council) and to be administered and the income thereof applied into the manner and for the purpose set forth in the Scheme of which particulars are contained in the Second Schedule hereunder written.

SECOND SCHEDULE ABOVE REFERRED TO

- 1. The Properties mentioned in the First Schedule shall be constituted into a Trust Fund which shall henceforth be known under the name and style of the "MAHARANI LAKSHMIVATI OF DARBHANGA TRUST FUND", the corpus of the Fund shall be left intact for ever.
- 2. The Persons to administer the said Trust Fund under the Section 5(1) of the Charitable Endowments Act (VI of 1890) shall be :-
 - 1. The District Magistrate, Darbhanga, President (Ex-Officio)
 - 2. The Sub-Divisional Officer, Madhubani (Ex-Officio)
 - 3. The District Inspector of Schools, Darbhanga, who whall also be the Secretary of the Board of Administration (Ex-Officio).
 - 4. An Expert in Sanskrit Educetion to be nominated by the Government of Bihar and Orissa.

- 5. The Manager of the Donor(Ex-Officio) during her life time and after the demise of the donor, a member of her family appointed by the Covernment of Riber and Orison.
- The Tressurer of Charitable Encomments shall my the income received from the said Trust to the District Magistrate of Darbhangs one of the Administrators who shall keep account of all sums received and spent and shall submit an Annual Account thereof to such public servant and in such form as the local Government may from time to time prescribe.
- Maintenance of a Middle School and a Sanskrit Fathabala existing at Village Sarisab in the Sub-Division of Madhubani in the District of Darbhanga called respectively the Lakahnishwar Academy and Lakahnivati Pathashala and there shall never be made any change, by addition or alteration or in any other way, in these names and they shall remain intact as they have been maded above for ever.
- 5. It shall be competent for the mid administrators to appoint -e a managing committee consisting of not less than five members, one of whom shall be them Dispector of Schools of Dorbhangs (Ex-officie) as Secretary of the Committee, with such powers as they may from time to time choose to give it. The Members shall ordinarily hold office for a term of five years and shall not be removed before the expiry of that term provided that any member may be reserved by the Administrators for misconduct or incorpolity to set, and in came of any vacancy in the committee, before the completic of that five years, caused by the death, unwillingness and incapacity to act, resignation or misconduct of any member, the same shall be filled up by an election, to be held by the remining members of the said Committee, for the remaining periods subject to the approved of the Board of Administrators, and as the expiry of every five years fresh committee shall be framed by the Board of Administrators and any member or members of the previous Committee may be reappointed.

- the said Managing Committee shall elect one or more members from among themselves, with such powers as they deem proper, and any vacancy caused by the death, unwillingness and incapacity to act, resignation or misconduct of any of the said supervising members, shall be filled by the Managing Committee by a fresh election as provided for before.
- 7. The said Managing Committee shall elect one of their respective members present at any meeting to be President of the Meeting and all business at such meeting or at a meeting of the Administrators shall be decided according to the votes of majority and in case of an equal division of votes, the President shall have a casting vote.
- 8. At all Meetings of the Administrators and the Managing
 Committee three persons shall form a quorum and the meeting
 of the Administrators wherever possible and of the Managing
 Committee ordinarily shall be held in the premises of the
 said School or the said Pathashala and Minutes of the Meetings
 shall be recorded and maintained.
- Administrators to improve the status and scope of the said School and Pathashals in such manner and to such extent as may be deemed, under the then existing circumstances proper. If for any unforeseen reason help be necessary for the maintenance of the said institution it will be competent to the Administrators to seek help from Government or the District Board in the shape of a "GRANT IN AID " in order may they deem expedient.
